

Subject:- Filling up the posts of Inspector (Junior Research Officer) (JRO) in Delhi Police on deputation basis.

I am directed to state that the applications are invited from willing and eligible candidates working under the Central/State Govt./UTs for the appointment to the post of Inspector (Junior Research Officer) (JRO) in equivalent grade {in the level -7 (pay Matrix 44900-142400) (9300-34800 + 4600 GP pre revised)} in Delhi Police on deputation basis.

The eligible terms & Conditions for the above mentioned posts are as under:-

1. **Inspector (JRO) (ONE POST)**

2. Qualification:-

- (i) Master's degree in statistics, Mathematical Statistics, or equivalent degree in Maths, Economics, Commerce, Physics, Sociology or Criminology with at least one subject on General Statistics from a recognized University.
- (ii) 3 years' experience in research involving collection, compilation, analysis and interpretation of statistical data.
- (iii) Desirable: (i) 2 years post-graduate diploma in Statistics from a recognized University or equivalent except in the case of person with Master's degree in Statistics, Mathematical Statistics, (ii) Experience in electronics data processing and analysis of crime, criminal statistics will be preferred.

(3) Health :-

The candidate should be of sound health free from disease/defect/debility.

(4) Method of recruitment:-

By deputation.

(5) In case of deputation, grade from which deputation to be made

Deputation shall be from the person serving in GNCT of Delhi/Govt. of India Statistical Assistants/statistician holding analogous post in equivalent grade or having 06 years experience in the pay matrix level 6 (Rs. 35400- Rs. 112400) [pre revised grade of Rs. 5500-175-9000]

**TRAINING:-** The candidates will have to undergo short training at Police Training College, Jharoda Kalan, Delhi for discipline, wearing of uniform, knowledge of Police Organizations, Rule and Regulation of Delhi Police.

The period of deputation will be one year extendable not more than 03 years. The maximum age limit for appointment by deputation shall be not exceeding 56 years as on the closing date of the receipt of applications.

The officers inducted on deputation will be governed by the standard terms and conditions of deputation as laid down in the Government of India DoP & T OM No. 6/8/2009-Estt. (Pay.II) dated 17 June, 2010 and amended from time to time.
