(PROMOTION LIST FOR CONSTABLE (EXE.) TO HC(EXE.)(MALE) THROUGH  
COMPETITIVE EXAMINATION – 2017-18)

1. The process of bringing the names of eligible Constables (Exe.) (Male) on Promotion List for the post of HC(Exe.)(Male) through competitive examination – 2017-18 has again been initiated. The tentative schedule for holding the tests is enclosed.
2. According to rule 12(1) and rule 20 of the Delhi Police (Promotion & Confirmation) (Amendment) Rules, 2015 and 12(2) Delhi Police (Promotion & Confirmation) (Amendment) Rules, 2018 as well as SO No. 91/16 & Amendment has been issued vide No.1101-1250/HAR (PHQ) dated 23.05.2018, all confirmed Constables (Exe.) (Male) with minimum 5 years of service and not more than 35 years of age as on 31.3.2017 are eligible to appear in the test.
3. All eligible Constables (Exe.) (Male) who wish to appear in the test can obtain copy of Application Form from INTRA-DP and their applications should reach in the offices of their respective DCsP latest by **03.06.2018**. The concerned DCsP should prepare the service particulars of the candidates on the prescribed proforma, to be collected from INTRADP, and keep them in their custody and get them fed on (INTRANET) INTRADP in a module under Web PIS in their respective offices latest by **17.06.2018**. After making entries, all the records of Distts/Units, database will be closed and a master report will be generated and sent back to all DCsP by I.T.C./PHQ for verification and signature.
4. It should be ensured that wide publicity is given to this notice by displaying its copies on all notice boards and also announcing, daily in the Roll Call up to last date of submission of application forms. Besides, eligible Constables (Exe.) (Male) who may be on leave, deputation or otherwise away from the Distts./Units Hdqrs., may be informed by quickest possible means against their proper receipt to avoid any further complication at the later stage. The applications received after the last date, are liable to be rejected.
5. **The Constables (Exe.) (Male), who have been given adverse (C) report during the last 5 years i.e. from 01/04/2012 to 31/03/2017 even for a small period of a year are not eligible to appear in the 'A' list test and his record should not be fed. Individual may also be informed accordingly.**
6. The applications of Constables (Exe.) (Male), who are seeking exemption from Out Door Test, must be sent to this Hdqrs. through DCP/concerned latest by **04.06.2018**, after proper examination in accordance with the provision of S.O. No. 91/2018.
7. S.O. No.91/2016 has already been circulated vide this Hdqrs. No.2969-3094/IIAR (PHQ) dated **22/06/2016** and amendment has been issued vide No.1101-1250/HAR (PHQ) dated 23.05.2018, which is also available on WEBSITE of Delhi Police, i.e. [www.delhipolice.nic.in](http://www.delhipolice.nic.in) as well as on INTRADP.
8. Any subsequent change in the service particulars of the applicant should invariably be sent by concerned DCP to PHQ till final result is announced. After that no claim of any Good/Bad entry will be considered. **Besides, it may be ensured that the service particulars fed in the INTRADP are of only Constable (Executive Cadre) (Male) and a certificate in this regard may also be furnished to this Hdqrs.**

9. As per SR 202 of Swamy's compilation, it shall be the duty of every Head of Office to initiate action to show the service book to the Govt. servant under his administrative control every year and obtain his signatures. In view of this the Ch. Rolls may be shown to the individuals before feeding the service particulars on INTRADP for avoiding representations by the candidates in this regard.
10. No electronic gadgets/equipment or Cell Phone is allowed during the test either in Out Door Test or in Written Examination. Possession of any such equipment or Cell phone will amount to disqualification of the candidate from the test/examination.
