Subject: - Publication of Seniority List of Inspector (Computer).

In continuation of this Hdqrs. U.O. No.71271-280/CB-V/PHQ, dated 24.11.2020 vide which this Hdqrs. has published a seniority list of Inspectors (Computer) of Delhi Police as on 24.11.2020 and the representations, if any, were also invited within a period of 30 days from the date of its issue. The said seniority list was published subject to further orders/instructions which may be arrived out at in pursuance of orders of the Hon'ble High Court of Delhi in Writ Petition (Civil) No. 3386/2005- Sandeep Malhotra Vs. UOI & Others and Writ Petition (Civil) No. 6172/2003 - Commissioner of Police, Delhi Vs. Sandeep Malhotra & Anr.

Aggrieved with the above seniority list, Inspr. (Computer) Sandeep Malhotra, No.D-I/135 (PIS No.16950001) submitted a representation stating therein that his seniority has been shown fixed at Srl. No.5 from the date of his officiating promotion i.e. 13.12.2005 whereas his seniority should be fixed from the date of Out-of-Turn promotion as Inspr. (Computer) i.e. w.e.f. 19.03.1998. The representation of Inspr. (Computer) Sandeep Malhotra, No.D-I/135 (PIS No.16950001) has been examined and found that his ad-hoc promotion in the rank of Inspector (Computer) on out of turn basis granted vide this Hdqrs. order No.15098/CB-VI (PHQ), dated 19.03.1998. Subsequently, he was regularized to the post of Inspector w.e.f. 13.12.2005 vide notification No.83214-31/CB-V/PHQ, dated 15.12.2005. It is a well settled law that the seniority of a promotee officer is reckoned from the date of his regular promotion. However, the case of Inspr. (Computer) Sandeep Malhotra regarding out of turn promotion is still subjudice in the Hon'ble High Court of Delhi. Any decision for change of date of regular promotion of the representationist, at this stage, shall be prejudice. Therefore, the representation is not tenable being devoid of merit.


